| Residency or Address Requirement | Address OR description of place of residence (ex: streets or landmarks nearby, does not need to be specific)  |
| ID requirement                   | Does not require voters to present photo identification. However, some voters may be asked to show a form of identification when voting if they are voting for the first time after registering to vote by mail and did not provide a driver license number, California identification number, or the last four digits of their social security number. Photo ID OR official document with voter's name and address are acceptable for voting. Can register online without ID |

| In-Person Voting:<br>Tuesday, November 5, 2024             | When you arrive to vote at the polls on Election Day in California, you do not need to show ID unless it is your first time voting in a federal election. First-time voters may need to provide identification if they did not include it when they registered. Accepted forms of ID can include a driver's license, state ID card, or utility bill. (California Elections Code 14216). |
| Absentee or Mail-in Voting<br>Deadline: October 21st, 2024 | California voters can request a mail-in ballot up to 7 days before Election Day. All registered voters in California are automatically mailed a ballot, but voters can also request a replacement or confirm their mailing address via the Secretary of State's website or by contacting their County Elections Office (Find your County Elections Office                               |
