Residency or Address Requirement	Can give address of shelter or list place they usually stay (ex: corner)
ID requirement	D.C. does not require identification from most voters. It requires voters who submitted their voter registration application by mail or online without one of the following documents to present one the first time they vote: a copy of a government-issued photo ID showing name and address, a government-issued document showing name and address, or a utility bill, bank statement, government check, or paycheck showing name and address issued within the past 90 days, a current residential lease or rental agreement, an occupancy statement from a District homeless shelter issued no earlier than 90 days before the election, or a tuition or housing bill from a District of Columbia college or university issued for the current academic or housing term

In-Person Voting: Tuesday, November 5, 2024	On Election Day in Washington, D.C., you do not need to show identification to vote unless it is your first time voting in a federal election and you did not provide ID when you registered. Accepted forms of ID for first-time voters include a driver's license, utility bill, bank statement, or government-issued document with your name and address.
Absentee or Mail-in Voting Deadline: November 15th, 2024	Washington, D.C. voters can request a mail-in ballot up to 7 days before Election Day, by October 29, 2024. D.C. automatically mails a ballot to all registered voters. If you need to request a replacement ballot or verify your mailing address, visit the D.C. Board of Elections website or contact the Board at (202) 727-2525.
