Residency or Address Requirement	Address OR short description of place of residence (street corner, park, shelter).
ID requirement	Nevada does not require voters to present identification while voting in most cases. A voter in Nevada must sign his or her name in the election board register at his or her polling place. The signature is compared with the signature on the voter's original application to vote or another form of identification, such as a driver's license, a state identification card, military identification, or another government-issued ID. However, Driver's license or other ID is required for online registration.

In-Person Registration Deadline	Available up to and including on Election Day, Tuesday, November 5, 2024
Mail-in Registration Deadline	Postmarked by Tuesday, October 8, 2024
Online Registration Deadline	Thursday, October 31, 2024

Voter Assistance or Accessibility	Voters with disabilities can use EASE, which allows for independence and enables covered voters to register, request, mark and return their ballots from their own homes. EASE is available for elections with a federal contest on the ballot 45 days before Election Day at <a href="https://www.nvease.gov">NVEASE.gov</a> .

In-Person Voting: Tuesday, November 5, 2024	Available on Election Day, Tuesday, November 5, 2024. The voter's signature is compared with the signature on the voter's original application to vote or another form of identification, such as a driver's license, a state identification card, military identification, or another government-issued ID.
Absentee or Mail-in Voting Deadline	Requests for an emergency absent ballot must be made in writing and submitted any time before 5:00 p.m. on the day of the election. Such requests must be due to an illness or disability resulting in confinement to a medical facility (includes nursing homes), sudden hospitalization, serious illness, or being called away from home after the time has elapsed for requesting a standard absentee ballot.
Early Voting	Early voting begins on Saturday, October 19 and runs through Friday, November 1.
