Residency or Address Requirement	A citizen can provide an alternative description of their residence, even if they are experiencing homelessness, as long as it enables the authorities to identify and assign a voting precinct to them. The mailing address on their registration form can be a PO box, local shelter, advocacy organization, outreach center, or the home of someone who will accept mail for them.
ID requirement	Wyoming residents must show proof of identity/residence by presenting identification and/or documents when registering. Information on ID requirements can be found here: https://sos.wyo.gov/Elections/State/RegisteringToVote.aspx Wyoming voters are required to show an acceptable form of identification when voting in person. If you do not have acceptable ID, you may obtain a free Wyoming Identification Card from your local Driver Services office.

<p>Voter Assistance or Accessibility</p>	<p>Wyoming State law allows ONE person to assist a voter in the following situations: blindness, disability, or inability to read or write. This person cannot be the voter's employer, an agent of the voter's employer, or an agent or officer of the voter's union. Please contact your County Clerk with any questions about polling place accessibility.</p>

<p>In-Person Voting: Tuesday, November 5, 2024</p>	<p>Voters are required to show an acceptable form of identification when voting in person or when requesting an absentee ballot in person. Any of the following will be accepted: WY Driver's License or ID Card, Tribal ID Card, Valid US Passport, US Military Card, DL or ID Card from Another State, University of Wyoming Student ID, Wyoming Community College Student ID, Wyoming Public School Student ID, Valid Medicare or Medicaid Insurance Card, Valid Wyoming Concealed Firearm Permit. If you do not have one of the documents in the list above, you may obtain a free Wyoming Identification Card from your local Driver Services office.</p>
<p>Absentee or Mail-in Voting Deadline: Postmarked by October 16, 2024</p>	<p>Registered voters may request an absentee ballot from your county clerk at any time during an election year, but not on the day of the election. To request an absentee ballot, call or write your county clerk. You do not have to give a reason for requesting an absentee ballot. Absentee voting begins 28 days prior to the election (45 days for military or overseas voters) and ends the day before the election.</p>
