REGISTER TO VOTE IN ALABAMA



Residency Requirement	You must be a resident of Alabama and the county listed on your registration. If you move from one county to another you must register to vote in your new county of residence.

HOW TO VOTE IN ALABAMA

YOU DON'T NEED A HOME TO VOTE

Voting with a Criminal Record	If you have been convicted of a crime of "moral turpitude" you may not vote unless your right to vote has been restored. If you have been convicted of treason or "impeachment" you may not be pardoned and the loss of right to vote is permanent. If you were convicted of certain felonies, i.e. murder, rape, sexual abuse or matters involving child pornography, you may not vote unless you have been pardoned and your right to vote has been restored. If you have been convicted of other crimes, and if you have no pending criminal charges, completed your sentence and parole/ probation, and have paid all fees, fines and restitution, you can apply for a Certificate of Eligibility to Register to Vote. The application process must be completed at least 60 days before an election. If you are currently incarcerated with a non-disqualifying felony, you are able to register to vote and to vote by absentee ballot. The necessary forms can be obtained from the facility warden or sheriff.

Voter's unable to provide photo ID at the time of the election shall be permitted to vote by provisional ballot. Mail-In	If mailed must be POSTMARKED by Nov. 2 and received by noon on Nov. 3. If hand-delivered must be in the office of the Absentee Election Manager by no later than 5:00 pm on Nov. 2.	Go to the website for absentee voting shown on the other side of this card. Last day to request ballot-by-mail is Oct. 29, 2020.	Ballots include 3 envelopes. A plain (secrecy) envelop, an affidavit envelop, and a pre-addressed envelope. Ballot must be sealed in the plain envelope and placed in the affidavit envelope which must be sealed and signed either before a notary public or two witnesses over the age of 18. The two envelops must then be placed in the pre-addressed envelope. The ballot must be received by NOON on Nov. 3 if sent through the mail. If delivering by hand the ballot must be hand delivered to the Absentee Election Manager by the close of business on Nov. 2.

REGISTER TO VOTE IN ALASKA



Residency Requirement	In order to register to vote, you must be both a US Citizens and an Alaskan resident over the age of 18 in order to register to vote. Further, you must not be registered to vote in another state unless you are willing to cancel your registration in that state. You must be a resident of the Alaskan county listed on your registration. For voting purposes, you are considered an Alaska resident if you reside in the state and intend to remain a resident or, if you temporarily leave the state, you have intention to return. A complete physical residence address in Alaska must be included on your application, regardless of whether you actually live there. The residence address you provide will be used to assign your voter record to a voting district and precinct. If you live in rural Alaska, you may provide the community name as your residence address. Please note that you can register to vote in Alaska as soon as you arrive in the state with an intent to remain a resident; however, you may only vote if you have been a resident of the state and of the election district in which you seek to vote for at least 30 days before an election.

HOW TO VOTE IN ALASKA

YOU DON'T NEED A HOME TO VOTE

Voting with a Criminal Record	In order to register to vote, you must not have been convicted of a felony involving moral turpitude, unless your voting rights have been restored. If you are no longer serving a sentence and have been unconditionally discharged from supervision by the Department of Corrections, you can register to vote in Alaska. The Division of Elections must receive proof of your unconditional discharge from the supervising entity. If you do not have a letter or discharge papers, please contact your probation or parole office to obtain one and submit it to the Division of Elections. REGISTER TO VOTE IN CALIFORNIA



Residency Requirement	You must be a United States citizen and a resident of California, and you must be 18 years old or older on Election Day. If you become a California resident less than 15 days before the next election, you must visit your county elections office at least seven days before Election Day and sign an oath saying you are eligible to vote in California and have not voted in the same election in any other state. In this situation, you may only vote for President or Vice President.

HOW TO VOTE IN CALIFORNIA

YOU DON’T NEED A HOME TO VOTE

Voting with a Criminal Record	You may not register if you are currently imprisoned in a state or federal prison; currently serving a state prison sentence in a county jail or other correctional facility or are in county jail awaiting transfer to a state or federal prison for a felony conviction or currently on parole with the California Department of Corrections and Rehabilitation or in county jail for a parole violation. You can register to vote: if you are in county jail serving a misdemeanor sentence (a misdemeanor never affects your right to vote); if you are in jail because jail time is a condition of probation (misdemeanor or felony); if you are in jail serving a felony jail sentence; if you are in jail awaiting trial; or if you are on probation, on mandatory supervision, on post-release community supervision, on federal supervised release or a person with a juvenile wardship adjudication.

In-Person	November 3	In most cases, a California voter is not required to show identification to a polling place worker before casting a ballot. However, if you are voting for the first time after registering to vote By Mail and did not provide your driver license number, California identification number or the last four digits of your social security number on your registration form, you may be asked to show a form of identification when you go to the polls. In this case, be sure to bring identification with you to your polling place or include a copy of it with your vote-by-mail ballot. Photo identification or copy of a recent utility bill, the sample ballot booklet you received from your county elections office or another document sent to you by a government agency are examples of acceptable forms of identification.
